Melanie Modica is an Accredited Senior Appraiser (ASA) for fine art personal property, with the American Society of Appraisers (ASA). She is also accredited with the Appraisal Review & Management (ARM) designation and specializes in appraisal review services, with and without opinions of value, for litigation support. Melanie is a designated expert witness in Texas, offering appraisals and appraisal reviews for litigation support and litigation consulting. She also offers umpire services. Additionally, Melanie is an Accredited Member of the International Society of Appraisers (ISA).

Having written the ASA Principles of Valuation *Managing Multifaceted Assignments* course for the ASA, Melanie also specializes in managing teams of appraisers when assignments involve various property types requiring multiple valuation experts.

Melanie serves, and has served, the ASA organization as a Senior Instructor for three Principles of Valuation (POV) courses that are educational offerings for professionals seeking appraisal designations, and as a contributor for the fourth of four courses. In addition to instructing professionals in appraisal review and management methodology, Melanie is a curriculum developer or contributor for these ASA courses, as well as an international instructor. She currently serves on the Board of Examiners for members credentialing with Appraisal Review & Management, for the Personal Property discipline.

She is the primary developer of the POV courses titled *Managing Multifaceted Assignments*, and *Valuation Review Report Writing*, two classes written according to two different standards, the Uniform Standards of Professional Appraisal Service USPAP, and the International Valuation Standards IVS. With a colleague, she created and chaired the *ASA Global Valuation Review Symposium, World Tour*, which was a three-day educational series for professionals around the world. Melanie was also the primary developer for a valuation review manual written for the government of a middle eastern country. Melanie is currently serving the ASA on the ARM Committee as the elected Vice Chair and has served as the Education Chair. She was the creator and inaugural editor of the ARM e-Journal, which is a quarterly publication.

Melanie Modica served as the Forensic Expert Witness Association (FEWA) Vice President of Education for two terms in 2020 and 2021. She also served as the South Region Representative for 2022, as well as the Alternate Representative for the South Region in 2023.

Melanie founded Modica Fine Art Appraisal LLC, now Modica Fine Art LLC, in 2009. MFA appraisals and appraisal reviews are written in compliance with the Uniform Standards of Professional Appraisal Practice (USPAP), which is the appraisal standard of care in the United States and in some countries worldwide.

Melanie offers fine art appraisal services for insurance coverage, loss claims, claim settlements, estate planning, divestment, dissolution of marriage, and more. She offers appraisal reviews for dispute
